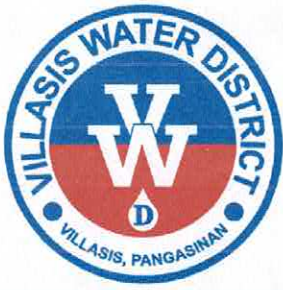

The unserviceable properties for sale are available for inspection/viewing from **September 28, 2021 to October 1, 2021** at the VWD Warehouse (Pump Station 2, Licsab Road, Brgy. San Nicolas, Villasis, Pangasinan.

Individuals, partnerships and/or corporations are qualified to participate in the public auction, subject to the submission of qualification documents, as may be required by VWD. Duly authorized representative/s, if any, shall submit a certification issued by the Head/Manager/Owner of the company, as may be applicable, authorizing him/her to speak and submit bids in behalf of the latter.

Deadline for the submission of bids shall be on **October 04, 2021** at exactly **9:00 AM** at the VWD Main Office (Bagsakan Market, Brgy. Poblacion Zone I, Villasis, Pangasinan)

Prospective bidders shall conform the following **TERMS AND CONDITIONS** that apply to the public bidding of various unserviceable properties of VWD, as follows:

1. No bid shall be allowed lower than the said floor prices.
2. The bidders shall register their names and addresses at the logbook or attendance sheet at the date of the submission of bids, indicating the Lot No/s. they wish to bid, and shall submit a photocopy of their Community Tax Certificate (for individuals) or Mayor's or Business Permit (for Partnerships or Corporations). Bidders who will participate in the public auction thru *viva voce* shall be given numbers to be used and strictly follows the **SOCIAL DISTANCING** during the auction.
3. During the Public Bidding, the bidders will bring with them the original copies of abovementioned documents for authentication/validation. Failure of the bidders to submit the said documents and present the original copies shall be a ground for disqualification.
4. Bids received shall be opened on exact time and date prescribed in the Invitation to Bid. Abstract of bids shall be prepared wherein the highest price offered for each lot shall be the winning bid, provided that the amount shall be higher or equal to the floor price.
5. Immediately after the winning bidder has been declared by the Committee, the winning bidder's bid bond shall be considered as partial payment for the bid and the difference in the amount between the bid and the bid bond shall be paid in the form of cash, cashier's or manager's check within five (5) working days from the date of receipt of the Notice of Award and to Proceed (NAP).
6. Upon payment of the full price, the winning bidder shall be the recipient of unserviceable properties or waste materials, and is required to haul the same within seven (7) working days. Bidder who has environment-friendly facilities and manner of recycling/disposal will be preferred.

This ITB will be posted in at least three (3) public places in the locality and at the VWD official website and Facebook page. The VWD Disposal Committee reserves the rights to reject any or all of the bids with or without cause, to annul bidding process, to waive any defect in them and to award the bidder whose bid is the most advantageous to the government.
