## INVITATION TO BID FOR *THE SUPPLY AND DELIVERY OF WATER SERVICE CONNECTION MATERIALS*

1. The *Villasis Water District*, through the *2018 Corporate Budget Approved by the Governing Boards* intends to apply the sum of *two million five hundred twenty-nine thousand five hundred sixty pesos (2,529,560.00php)* being the Approved Budget for the Contract (ABC) to payments under the contract for *the procurement of water service connection materials*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Villasis Water District* now invites bids for *the procurement of water service connection materials*.<sup>3</sup> Delivery of the Goods is required *on an installment basis*. *First delivery will be on May 2, 2018. Second delivery will be on July 2, 2018 and the third delivery will be on September 3, 2018*. Bidders should have completed, within *one year* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from *Villasis Water District* and inspect the Bidding Documents at the address given below during *Monday to Friday 8:00AM to 4:00PM*.
5. 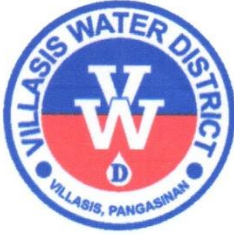

Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Villasis Water District now invites bids for the supply and delivery of water service connection materials. <sup>3</sup> Delivery of the Goods is required on an installment basis. First delivery will be on April 20, 2018. Second delivery will be on June 20, 2018 and the third delivery will be on September 20, 2018. Bidders should have completed, within one year from the date of submission and receipt of bids, a contract similar to the Project. 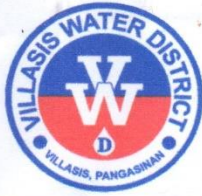
